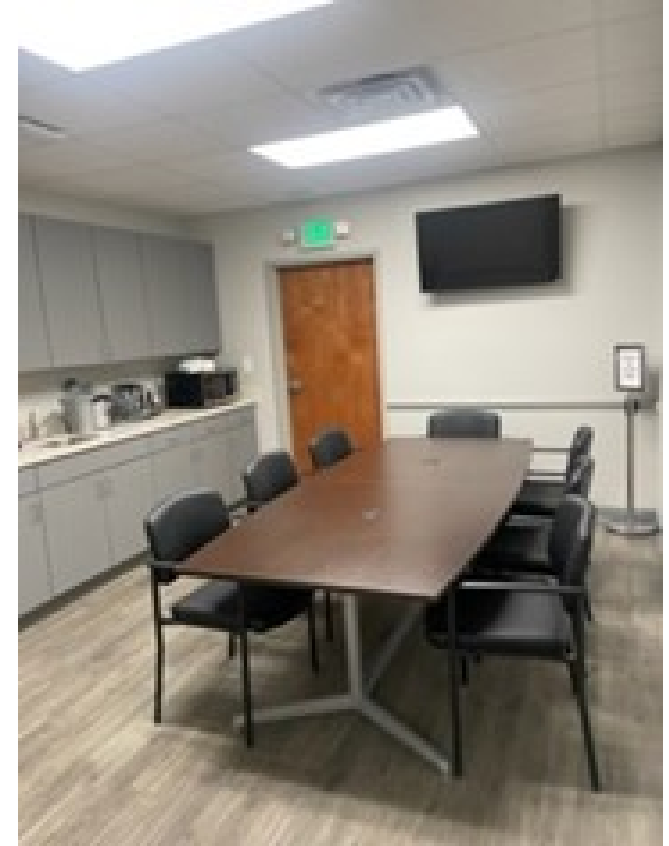

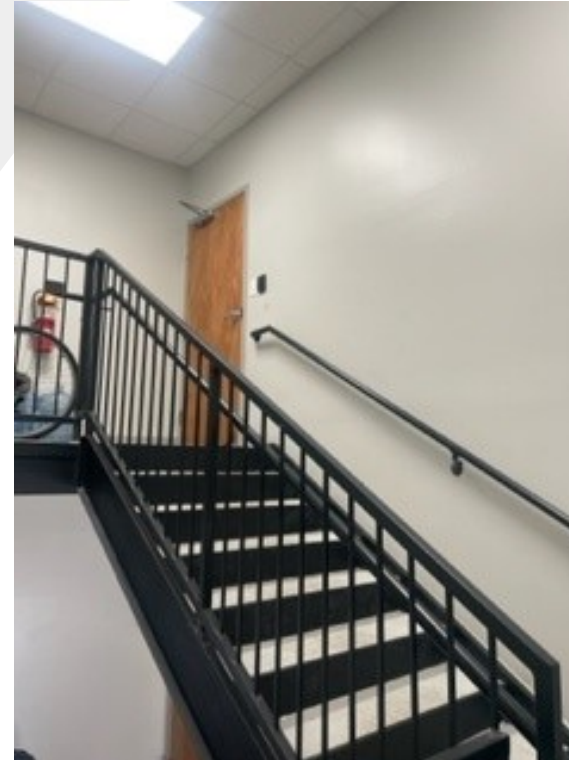
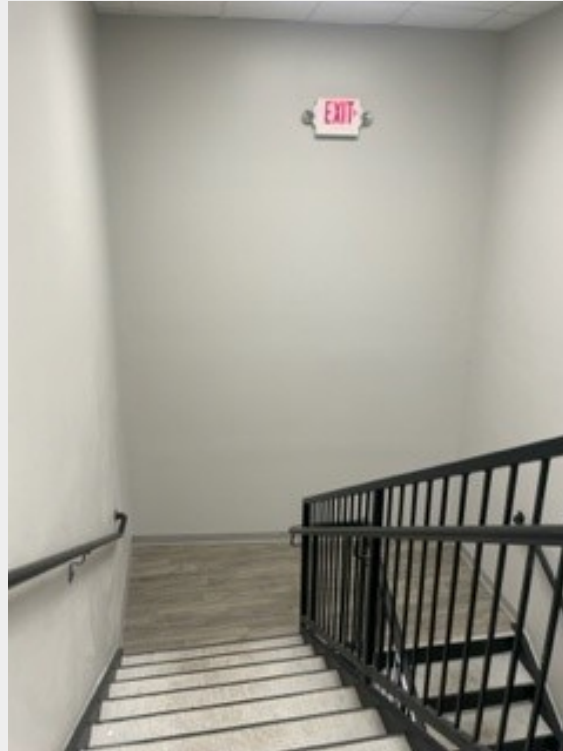
COMPARISON TO SUPERIOR COURT JURY DELIBERATION ROOM

CUBICAL AREA

PROBATE COURT SPACE ISSUES

- ✓ Effective July 2022 Rockdale County Probate Court will be reclassified as an Article 6 Court, a direct result of the population increase based on the 2020 Census
- ✓ Space needed to accommodate this uptick in customers and additional staffing for the increase in the caseload volume – i.e., Associate Judge, additional Deputy Clerks, Law Clerks, Interns
- ✓ Difficult to communicate and process customer's request with the limited cubical space, shared courtroom and rotunda area with Magistrate Court
- ✓ Compromising security and privacy issues with the current functionality of shared space
- ✓ Difficult to handle the volume of paperwork with small desks, which includes the computer, scanner, phone, and printer
- ✓ Space needed to allow access to Residents, Title Researchers and other Record Specialist to review and research public documents and vital records
- ✓ Space needed to structurally house a fireproof file cabinet for safe keeping documents

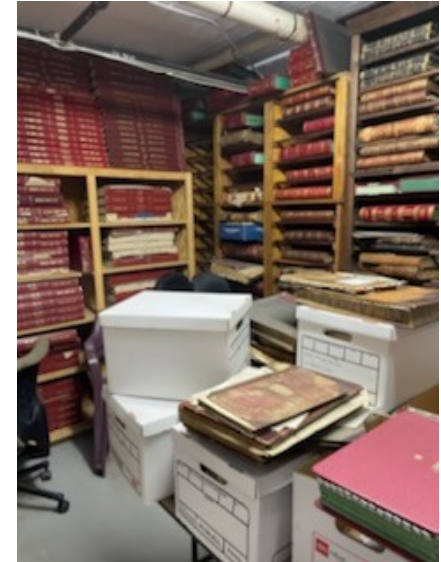
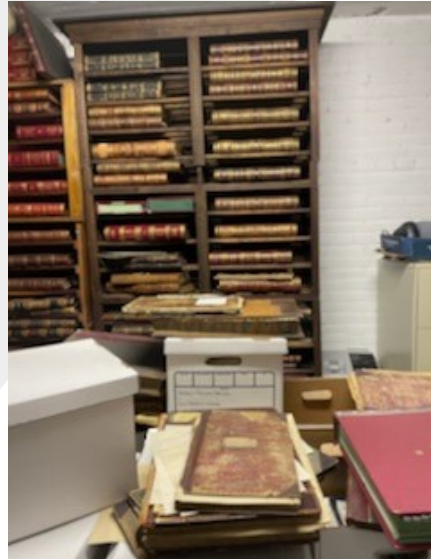
SPLIT LEVEL DEPARTMENT — CURRENT FILING SYSTEM
