WHEREAS, the Board of Commissioners will have a meeting recess in the month of February; and desires for businesses to have continuity of operations; and

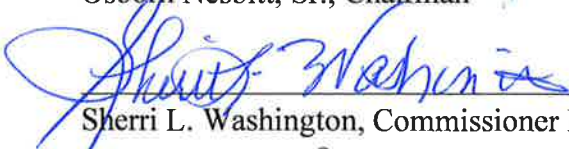
