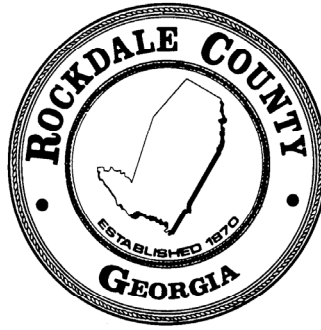

RFP #25-14 is hereby amended as follows:

1. Below are questions received and corresponding answers:

A. Question: Within the Scoring Matrix on page 15, the RFP indicates page counts for each section. Are these page limits? And is there a page limit for the entire proposal? Additionally, which items are excluded from a page limit? (ex: cover, table of contents, resumes etc.)

Answer: Disregard page limits.

B. Question: Regarding the "Relevant Company Experience" section on page 15, does "one page" refer to one page per project, or a total of one page for all projects combined?

Answer: Disregard page limits.

C. Question: For the "Relevant Staff Experience with Resumes" section on page 15, does "4 pages" mean 4 pages per resume, or a total of 4 pages for all resumes combined?

Answer: Disregard page limits.

D. Question: Would the County consider extending the due date by two weeks to allow for the submission of a more comprehensive proposal for this project?

Answer: No, the County will not be extending this RFP.

E. Question: On page 15, it states that relevant staff experience with resumes is to be on 4 pages? Can we not submit more than 4 resumes? Do resumes count or not count in page count? Do all our key personnel resumes need to fit in 4 pages?

Answer: Disregard page limits.

F. Question: Can the organizational chart be on 11X17 paper?

Answer: Hard copies will not be accepted. Submit a USB drive only.

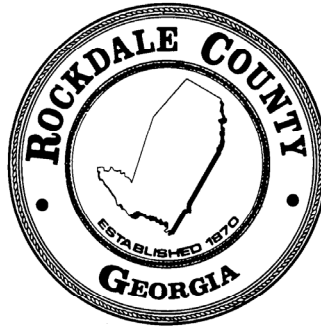
