WHEREAS, the Board of Commissioners of Rockdale County, Georgia, have entered into an agreement with Anthem Blue Cross Blue Shield, Kaiser Permanente, Aetna, and Delta Dental in order to provide health and wellness benefits to the employees and retirees of Rockdale County, and

WHEREAS, the Board of Commissioners of Rockdale County, Georgia desire to ensure the efficient and uninterrupted benefits to all employees, and

WHEREAS, Anthem Blue Cross Blue Shield, shall provide major medical and vision insurance. Kaiser Permanente shall provide major medical. Aetna shall provide Medicare Advantage for Rockdale County's retirees. Delta Dental shall provide dental insurance.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Rockdale County the Chair of the Board of Commissioners shall be authorized to execute contracts directly related to the existing health coverage and voluntary agreements with Anthem Blue Cross Blue Shield, Kaiser Permanente, Aetna, and Delta Dental. These contracts shall be subject to review by the Rockdale County Attorney.
