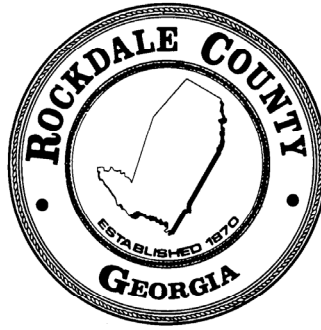

Addendum No. 1

**RFP No. 25-27
HOME DELIVERED MEALS FOR THE SENIOR SERVICES DIVISION**

December 30, 2025

RFP #25-27 is hereby amended as follows:

1. Below are questions received and corresponding answers:

A. Question: 60-80 meals per day. Are these individual meals? Can these be delivered frozen and heated at the congregate sites?

Answer: Meals must be delivered frozen to the Rockdale Site. Each meal must be individually sealed in a microwave ready container. Five different meals are included in each box. One box equals the meals for one client for one five day week.

B. Question: How many days per week for deliveries?

Answer: One, Mondays. When a holiday occurs on a Monday then the delivery date is Tuesday.

C. Question: For the Monday deliveries of frozen meals, how many cases per week? What is the case pack?

Answer: Frozen meals boxes should include five individual meals. Each week the number of boxes ranges between 60-80 depending on the number of clients.

D. Question: Estimated annual volume of shelf stable cases? Can we bid for either 5 or 7 or both?

Answer: Annual volume of shelf stable is approximately 500. Shelf stable bid can be offered as a 5 pack, 7 pack or both. Rockdale prefers to have the option of ordering 5 packs or 7 packs depending on client need.

E. Question: Who is the current provider of meals?

Answer: Open Hand Atlanta, Inc.

F. Question: If the 60-80 meals per day are hot meals, will you accept two vendors for this RFP?

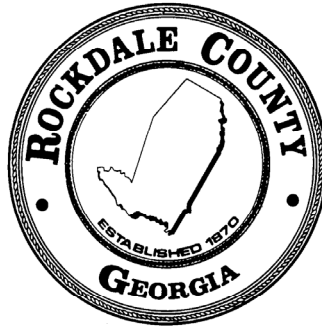
