**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF ROCKDALE COUNTY,
GEORGIA, ACKNOWLEDGING AND AUTHORIZING THE IMPLEMENTATION OF
ENVIRONMENTAL HEALTH FEES ADOPTED BY THE ROCKDALE COUNTY
BOARD OF HEALTH**

WHEREAS, the Constitution and the Official Code of Georgia Annotated (O.C.G.A.), Title 31 (Public Health), county boards of health are created and authorized to adopt rules and establish reasonable fees necessary to administer and enforce environmental health programs; and

WHEREAS, the Rockdale County Board of Health serves the residents of Rockdale County by promoting and protecting health and well-being by providing a wide range of services addressing all public health aspects; and

WHEREAS, the Rockdale County Board of Health, at a duly called meeting held on August 8, 2025, adopted an Environmental Health Fee Schedule to recover the reasonable costs associated with providing environmental health services; and

WHEREAS, pursuant to the laws of the State of Georgia, O.C.G.A. §31-3-4(a)(6), a schedule of fees must be approved by the county governing authority; and

WHEREAS, the Rockdale County Board of Commissioners are the governing authority of Rockdale County, Georgia, a political subdivision of the State of Georgia; and

NOW, THEREFORE, BE IT RESOLVED by the Rockdale County Board of Commissioners to acknowledge and authorize implementation of the Environmental Health Fee Schedule as adopted by the Rockdale County Board of Health as set forth in **Exhibit A**, attached hereto and incorporated herein

BE IT FURTHER RESOLVED, this Resolution is to become effective immediately upon adoption and that any resolution in conflict with this resolution is hereby repealed.
