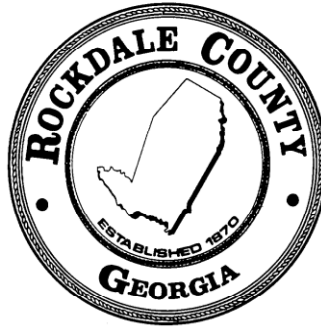

**ITB No. 26-08
PORTABLE MESSAGE BOARD**

ITB #26-08__ is hereby amended as follows:

1. Below are questions received and corresponding answers:

A. Question: I just wanted to clarify in the documents for this bid, it states that Rockland County needs our Business license from our home jurisdiction (Florida) & vendors doing business in Rockland County must also have a current Rockland County Business License. If we will not have a physical presence in Rockland County, items awarded in bid will be drop shipped from the manufacturer, do we need a Rockland County business license or not?

Answer: If your company does not have a physical business location in Rockdale County, Georgia, and the awarded items will be shipped directly from the manufacturer with no physical presence established in Rockdale County, you are not required to obtain a Rockdale County Business License for the purposes of this solicitation. However, bidders are required to provide a current and valid business license (or equivalent business registration) issued by the jurisdiction in which their business is physically located, as part of their bid submission.

B. Question: Also, regarding the submission of the bid, I get it is a mail in bid, but on page 2 "BID COPIES FOR EVALUATION" says 1 USB Flash Drive & 1 hard copy in ADOBE PDF format will be required for review purposes. NO hard copies will be accepted. So we are to mail in only a USB Flash Drive with 2 copies of our completed bid docs on it? As long as 1 of those saved files on the USB is Adobe PDF we are ok? You want no paper copies mailed in, is that correct? Is 1 USB flash Drive acceptable or is 2 needed?

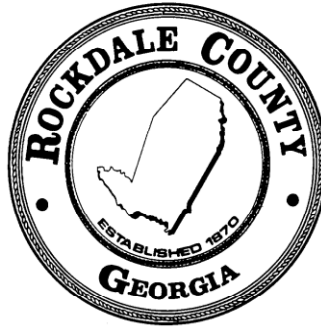
